## **FastVDO's H.264 Baseline Profile Decoder demonstration on Series 60 Mobile Platform**

**Scope:** This document describes the contents of .sis file, installation procedure for FastVDO's H.264 Baseline Profile decoder, and the steps to run the demonstration software on Series 60 mobile device.

**Target devices:** All devices supporting Series 60 Mobile Platform with ARM 9 processor. This installation has been tested for the following devices -- Nokia 6600, Nokia 6630, Sony Ericsson P900, Nokia N-Gage, Nokia 7610, Nokia 3600. It might work well with other untested devices also.

**Contents:** The installer provided contains FastVDO's H.264 Baseline Profile decoder and 4 test streams encoded at 3 different bit rates.

**Terms and conditions:** Please go trough the licensing agreement at the end of this document carefully before installing and redistributing.

#### **Installation procedure:**

To install the FastVDO's H.264 Baseline Profile decoder demonstration software on your mobile device, please follow the procedure given below.

1. Initiate the transfer of **FvDec.SIS** file onto your mobile device via BlueTooth® or Infrared. The device will receive the installation file as a message.





2. Select the message. This will start the installation of the software. You will receive a warning saying that the content is not from a trusted source. Select to continue.





3. The installation will create an "**FvDec**" icon in the **Menu**.







#### **Demonstration procedure:**

1. Select the **FvDec** icon from the **Menu** to start the FastVDO H.264 Baseline profile decoder demonstration software.



- 2. In the **Options** menu Choose any of the bit-rates (**32 kbps/48 kbps/64 kbps**).
- 3. In the next menu choose one of the H.264 compressed video file for playback.
